2. All applicants must be currently registered with the California Inland Empire Council.
3. No full camp scholarship are awarded. Partial camp scholarships will be awarded based on information provided.
4. Camp scholarships are non-transferable.
5. **CAMP SCHOLARSHIPS DO NOT QUALIFY FOR DISCOUNTED ACTIVITY FEES.**
6. Camp Scholarship forms does not reserve the Scout a place at camp
7. One camp scholarship per Scout. **No Duplicates.**
8. Assistance is only available for California Inland Empire Council.
9. Notification of funds awarded will be sent by email to Parent and Unit Leader.
10. Only complete applications will be considered; incomplete applications will not be reviewed.
